**4. REPORT FROM THE ASSISTANT SUPERINTENDENT**

Presentation from AVA SURE

Company owner Brad Playford is from Muskegon, and is looking to help with the classroom behavioral problems as well as working to improve the perception of the school and students. AvaSure's AvaSys allows healthcare facilities to use video monitoring of patients who would otherwise require a health professional to sit at their bedside. The monitoring is of both patients' and the patients' monitors that are in their rooms. AvaSure promotes AvaSys as a critical aid in reducing falls among patients. Avasure has found success with its AvaSys patient monitoring system used by hospitals, and is interested in expanding into the education arena. We will use the technology to assist the educator during class time with identifying factors influencing student's unproductive behaviors. Multilevel analyses revealed that while individual student characteristics had the largest influence on problem behavior, average prosocial behavior and concentration problems of students within the classroom, as well as teacher perceptions of the school climate significantly related to how students behaved. These findings support the use of classroom-based intervention programs to reduce student problems (L. O' Brennan, M. Furlong, Bradshaw,
